Print your name: _____ (hereinafter referred to as "Client") REPRESENTS: (1) there is good access to performance area (paved walkway, freight elevators only and **no stairs**) - exceptions can be made only with the inspection and approval of a Sassy Booths staff member, note that if access is not possible, there is absolutely no refund given, it is 100% the responsibility of the client to check all access points for fit (dimensions are on FAQ's page of website); (2) there is a 110 (standard "plug") electric outlet within 100 feet of the desired performance area; (3) there is a level, hard surface for the booth to be placed on. If the event is outdoors Client will be responsible for any damage done to the photo booth: (4) Client is responsible for any damage caused by Client or any of the Client's guests.

Sassy Booths OBLIGATIONS:

1. Provide an operational photo booth that does not require money to operate for the number of hours booked. Client acknowledges the booth will require onsite maintenance and/or servicing during the performance, and will operate for at least 80% of the length of the time booked as a result of that maintenance and/or servicing.
2. Provide a qualified technician onsite to maintain the unit in operating condition.
3. Install and remove the photo booth in a timely manner.

1. A deposit is required to hold the date and the remaining balance is due fourteen (14) days prior to the contracted event date. If balance due is not paid on time, deposit shall be forfeited and the photo booth reservation canceled.
2. Client and Sassy Booths agree that in the event of a mechanical failure, or for any other reason Sassy Booths is unable to provide a functioning photo booth pursuant to this agreement, Sassy Booths maximum liability is the return of any payments received. Sassy Booth will not be liable under any contract, negligence, strict liability, or other theory for direct, indirect, incidental or consequential damages (including without limitation, damages for lost profits or increased expenses) with respect to any claim arising from or related in any way to this agreement, the subject matter of this agreement, the services

provided under this agreement, or the property where these services are being performed. If Sassy Booth is only able to provide partial services for any reason, the charges to Client will be prorated subject to the 80% usage clause above.

3. Client and Sassy Booth agree that Client shall procure, at its/his/her expense, adequate general liability insurance naming Sassy Booths and its agents as additional insured's against any and all claims for bodily injury and property damage occurring in, or arising out of Sassy Booths performance of this agreement. Client agrees to indemnify and hold Sassy Booths harmless from all losses and/or damages incurred as a result of Client's failure to procure adequate insurance pursuant to this provision.

4. This agreement constitutes the entire agreement between Sassy Booths and Client with respect to the subject matter and performance of this agreement and supersedes all prior and contemporaneous oral, written and other agreements between the parties with respect to the subject matter hereof. This Agreement may only be amended by a writing signed by Sassy Booths and Client.

5. Client and Sassy Booths agree that any dispute or claim arising from this agreement or performance of this agreement, with the exception of Sassy Booths attempts to collect payment for its performance of this agreement, will be settled by voluntary mediation. If mediation is unsuccessful, the dispute will be settled by binding arbitration using an arbiter from the American Arbitration Association in Los Angeles, California. Client agrees to pay all of Sassy Booths reasonable attorneys' fees incurred in bringing a collection action to recover payment for services provided under this agreement. In the event Client and Sassy Booths are forced to arbitrate any claim or dispute arising from the performance of this agreement pursuant to this provision, Client and Sassy Booths agree that the prevailing party's attorneys' fees will be paid by the opposing party. This agreement shall be governed by and construed in accordance with the laws of the State of California without reference to the choice of law principles of any jurisdiction. If any provision of this agreement shall be held invalid or unenforceable, the remainder of this agreement, which can be given effect without such invalid or unenforceable provision, shall remain in full force and effect.
